# Privacy policy:

Additionally, for some e-mails sent in HTML format by New York ACEP to its members through its list servs and electronic newsletters, we will collect specific information regarding what the recipient does with that email. For those email messages, New York ACEP will monitor whether a recipient subsequently clicks through to links provided in the message. Other information collected through this tracking feature includes: email address of a user, the date and time of the user's "click," name of the list from which the message was sent, tracking URL number and destination page.
